

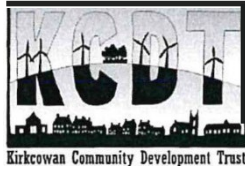
Kirkcowan Community Development Trust

Driving Test Grant Scheme Conditions and Guidance

The Driving Test Grant Scheme covers categories A (motorcycles) and B (cars) only

- Applicants must be resident in the Kirkcowan Community Council Area (KCCA).
- The Driving Test Grant Scheme covers only one driving theory test and one driving practical test for each applicant.
- Applicants must provide documentary proof of a test booking, clearly showing their name and address.
- As DVLA require payment at the time of booking, applicants must necessarily make payment to DVLA before submitting their grant application to KCDT.
- The Driving Test Grant Scheme does not cover extended driving tests nor tests completed prior to the introduction of this scheme.
- Applicants are required to inform KCDT of their test attendance.
- KCDT takes fraud very seriously and any such attempts will be reported to Police Scotland. If any evidence of fraud is found the person responsible will be disqualified from making any further funding applications to KCDT.
- KCDT reserves the right to require applicants to repay any monies granted through this scheme if any of the conditions relating to this scheme are not met.
